

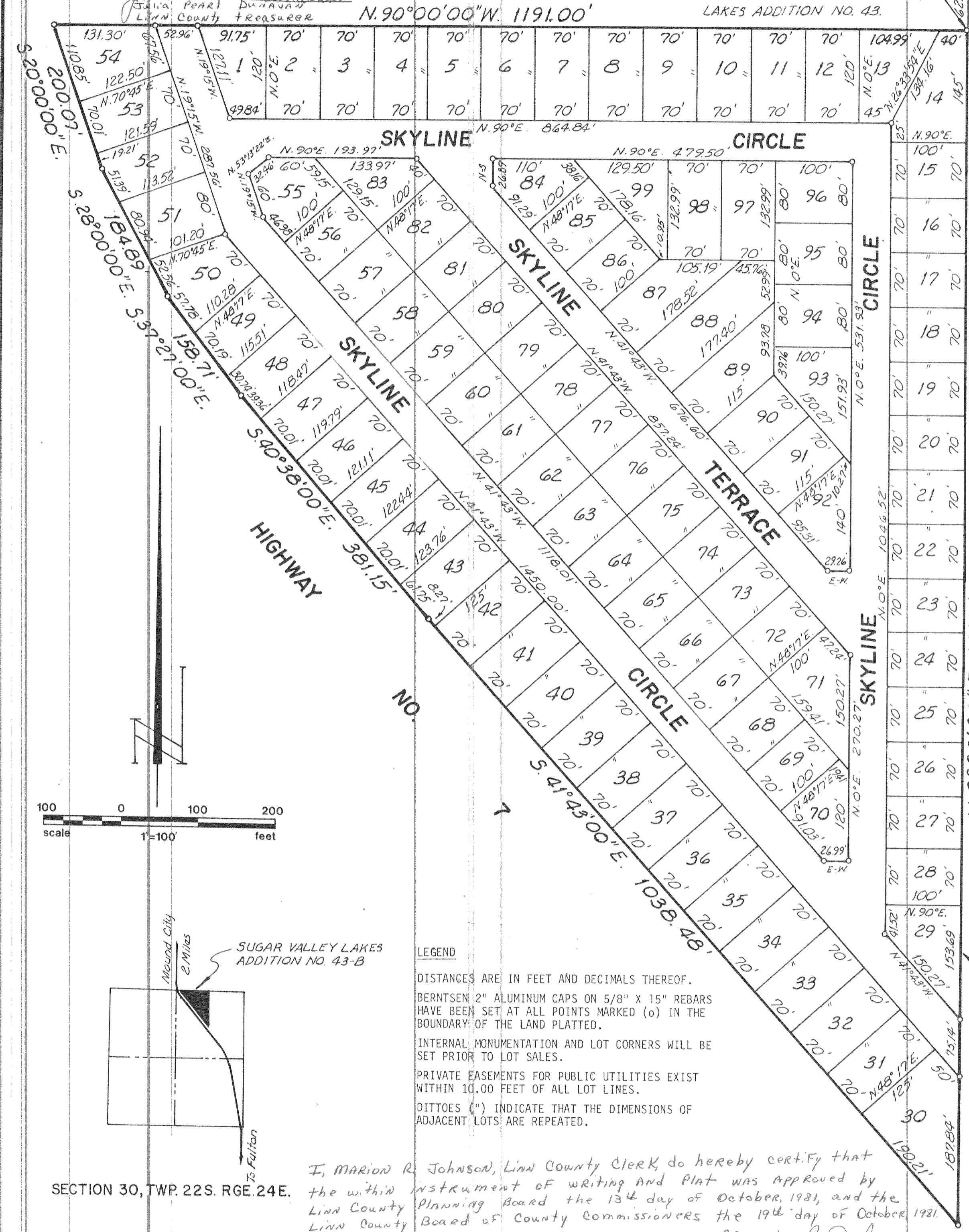

LEGAL DESCRIPTION: "SUGAR VALLEY LAKES ADDITION NO. 43-B", A REPLAT OF PART OF SUGAR VALLEY LAKES ADDITION NO. 43, A SUBDIVISION OF PART OF THE NORTHEAST 1/4 OF SECTION 30, TOWNSHIP 22 SOUTH, RANGE 24 EAST, LINN COUNTY, KANSAS, DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHEAST CORNER OF SUGAR VALLEY LAKES ADDITION NO. 43, SAID CORNER BEING A POINT 1353.18 FEET WEST AND 62.29 FEET SOUTH OF THE NORTHEAST CORNER OF SAID SECTION 30; THENCE NORTH 90°-00'-00" WEST, 1191.00 FEET; THENCE SOUTH 20°-00'-00" EAST, 200.07 FEET; THENCE SOUTH 28°-00'-00" EAST, 184.89 FEET; THENCE SOUTH 37°-27'-00" EAST, 158.71 FEET; THENCE SOUTH 40°-38'-00" EAST, 381.15 FEET; THENCE SOUTH 41°-43'-00" EAST, 1038.48 FEET TO A POINT ON THE EAST LINE OF SAID SUBDIVISION; THENCE NORTH 00°-00'-00" EAST ALONG SAID EAST LINE, 1541.67 FEET TO THE POINT OF BEGINNING. CONTAINING 23.46 ACRES, MORE OR LESS AND COMPRISING 99 LOTS NUMBERED 1 THROUGH 99 INCLUSIVE.

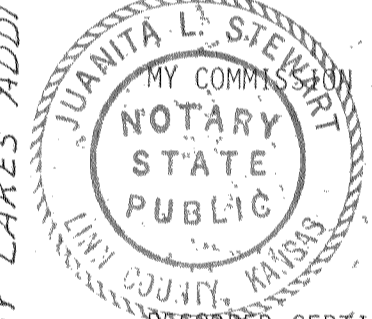
