

From the Office

Billing out and communicating with members is important for the continuing progress of our Association. Mail services seem to have been an issue in the last couple of years. In trying to improve communication, we have a Facebook page (sugar valley hidden valley lakes) and a new website that has a more up-to-date look and function. On the website there is a function to sign up for email notifications and we highly recommend registering so that you can get important information and updates within the communities. If you change your mailing address through the year you need to remember to call the office to make any changes. Verify your phone number and give us your email address so that we

can communicate with you if needed. As the number of returned invoices increase through the mail, we don't always get a forwarding address. If your bill continues to be returned, and the bill goes unpaid, we will have no choice but to send accounts to collections.

Invoices are sent out every year in November and the newsletter is sent out in December. If for some reason you do not get yours you should call the office to see if your information is correct. Yearly dues are due March 1st and will be sent to collections April 1st. Please be diligent in remembering your fees!

Payment options are always available! Please, if necessary, call the office to discuss payment options.

Security for the Association

Sugar Valley and Hidden Valley have security personnel that work diligently in keeping the flow of summer fun, safe & secure. Off-road vehicles that are driven on Association roads must be tagged through the clubhouses, providing current ownership (of the member) and liability insurance. This includes, but not limited to, golf carts, gocarts, four wheelers, mules, etc. Guests may not bring their recreational vehicles to the properties to use. With the communities growing there is more traffic, and also younger people on the properties, please be conscious of our 20 mph speed limit. As a member you are responsible for your guest's actions. Security's job is to keep our common properties safe. Security has no authority

to become involved in any private or domestic issue. Recreational vehicles are to be on Association roads only, privately owned (unless owned by the individual) and common properties are off limits. Our dams are regulated by the State of Kansas and any vehicle caught driving on the damns is subject to Kansas laws & penalties. Being at the beach is part of the summer fun! Be aware that if you have guests, you must be with them or they will be asked to leave any common property until the members is personally with them. Our properties are for members in good standing, if dues are not paid you will not be able to use the property for fishing, swimming, golfing, showering, etc.

Tips to help sell your lot:

- 1) Clear your lot
- 2) Mark your property lines
- 3) Get current on dues & taxes
- 4) List on craigslist or Facebook
- 5) Post it for sale in the clubhouse
- 6) List any extra amenities; fire pit, electric
- pole, camper pad, etc....

Committees Coming Together

Committees are vital to the future of our Association. Each community has a Lakes Committee that advises us of their particular need. A six (6) year fish restocking/feeding program is in place with each committee doing their fish selecting. In 2015 Sugar Valley raised from donations an extra \$2500 for added stocking, as did Hidden Valley a couple years ago. Improvements for the following are planned: water/boat safety, security, boat registration, and lake health and boat ramp surveillance.

Recreation committees are also making some changes! New committee members are bringing fresh ideas and excitement into our communities, watch for expansion of the monthly events. Keep your recreation schedule handy and please take the time to come, enjoy your community, get to know your neighbor and participate in your recreational community.
